

SCORECARD PROCESS AND NOTES

- Carriers are grouped by the uppermost parent company identified by AM Best Corporation, rather than by the NM WCA-assigned carrier number.
- The graphical information presented on the first page of each section is based on the 20 carriers and self-insured entities with the highest volume of indemnity SROI reports submitted for the preceding 12 quarters. The selection of carriers by volume of SROIs will automatically "phase-out" carriers that cease to conduct business in New Mexico, and "phase-in" those that increase volume or become active, as needed.
- Each quarter is presented as a stand-alone quarter that only includes data for that quarter. Additionally, a summary report for the year is prepared alongside Q4 to give carriers an overview of the year.
- ❖ The detailed listing of reporting results is listed alphabetically, rather than by Z-score.




