EDI CLAIMS STANDARDS ORDER OF THE DIRECTOR

This ORDER is issued pursuant to NMSA 1978, Sections 52-1-58, 52-3-51 & 52-5-4(A), and NMAC 11.4.2.8(C).

This ORDER constitutes the "EDI Claims Standards Order" required by NMAC 11.4.2, effective November 7, 2025.

The purpose of the ORDER is to establish the requirements, formatting and procedures for filing EDI data required by statute and administrative rule.

EDI CLAIMS STANDARDS ORDER

A. "EDI Claims 3.1 Standards" means the collection of New Mexico-specific technical implementation documents adopted by the New Mexico Workers' Compensation Administration (NMWCA) that specify the technical requirements, formatting, and procedures for submitting EDI data in compliance with the International Association of Industrial Accident Boards and Commissions (IAIABC) Electronic Data Interchange (EDI) Claims Release 3.1 Standard. These EDI Claims 3.1 Standards include the NMWCA EDI Claims Release 3.1 Implementation Guide, Element Requirement Table, Edit Matrix, Event Table, and Sequencing Table.

B. The following versions of the NMWCA EDI Claims Requirements Tables are hereby incorporated into this Order by reference and are identified as follows ("Rev" represents revision and 'v' represents version):

1. NMWCA Claims R3.1.6_Event-Table (Effective 11-07-25_Rev 09-26-2025) v1.2;
2. NMWCA Claims R3.1.6_Element-Requirement-Table (Effective 11-07-2025_Rev 09-26-2025) v1.2;

3. NMWCA Claims R3.1.6 _Edit Matrix Table (Effective 11-07-2025 _ Rev 09-26-2025)

v1.2; and

4. NMWCA Claims R3.1.6 _Squencing Table (Effective 11-07-2025 _ Rev 09-26-2025)

v1.2.

C. Pursuant to NMAC 11.4.2.8 (B)(2), EDI data must be submitted according to the technical requirements, formatting, and procedures set forth in the most recent versions of the EDI 3.1 Claims Standards.

D. The incorporated EDI 3.1 Claims Standards Requirements Tables shall be made available on the EDI 3.1 information website located at <https://nmwcaedi.info/requirements>.

E. The above specified NMWCA EDI Claims Requirements Tables govern the technical requirements, formatting and procedures for filing EDI data required by statute and administrative rule.
